The application process includes:

- A signature from the nominee agreeing to the nomination
- All nominations must be made on this Nomination Form and should be typed and submitted electronically.
- All sections must be completed as specified for the nomination to be eligible.
- Consent from the Referee is expressly required.

Submission Guidelines and Requirements

The Nominee:

1. Must be of Kastellorizian descent.
2. Must have demonstrated excellence in a field of endeavour and/or made an outstanding contribution to the Kastellorizian, Greek and / or Australian community.
3. Must be an inspirational role model for Kastellorizians.
4. Must agree to the nomination.
5. Able to attend Gala Dinner on October 21st in Perth 2023

Nominations:

1. Submissions can be made by members of any Kastellorizian Association or community group in Australia.
2. The closing date for 2023 WA State finalists is **28 August, 2023**.

Nomination Form requirements:

- All four parts (A – D) must be completed.
- Consent of the Nominee (Section A) given.
- All three Selection Criteria (Section B) must be specifically addressed under each heading.
- Extra supporting material (with a limit of 4 x A4 size pages) must be annotated, clearly explaining relevance to the specific Selection Criteria (Section B).
- A resume and/or biography is highly recommended (Section C).
- A referee, with their express consent (Section D) provided.
